Open Meeting Law Notice Requirements Under the Open Meeting Law, there are three kinds of meetings subject to varying notice requirements. Regular meetings refer to those meetings which are conducted routinely or on a prescribed schedule. Counties are required to keep a schedule of regular meetings on file at its primary office.
